 - Quick update from the ad hoc committee. I will not be able to attend area this month as I am traveling to compete at the world bench press championships, so I wanted to be sure to provide a written update for the May ASC meeting.

The committee met this month to discuss the ad go a purpose and conduct a current state analysis to better understand the current pain points and begin developing proposals for consideration by the area. We examined the current financial policy and found 3 primary areas of focus. The first involved the dual signature requirement and the lack of recognition by GA banking laws that create a false sense of security by utilizing dual signatures. The second has to do with the lack of written guidelines promoting best practices for requesting advances. The third issue involves the large transactional manner of the Lit chair and the fact that our practice has shifted, requiring the lit chair to either request an advance, or pay out of pocket, for monthly literature orders.

- These are the three issues we are focusing on and will discuss them in further detail at the next Area meeting at the end of the month. Our committee consists of Myself, Christian, Brian L, and Jan. Our next committee meeting will be June 18th at 8pm (virtual meeting). We look forward to bringing options to the floor for the area to discuss and for us to gather feedback on at the end of the month. Thank you for the opportunity to serve!
- Jan L. attended and said he could answer some questions if anybody has any questions.
